The Family Law Facilitator / Self-Help Attorney is a neutral person who does not represent any parent or party, however, can help you in preparing your own forms and can give you general information.

The Family Law Facilitator / Self-Help Attorney IS NOT YOUR LAWYER and cannot go with you to court. There is no attorney-client relationship between you and the Family Law Facilitator / Self-Help Attorney. The Family Law Facilitator / Self-Help Attorney may provide information and services to the other party in your case.

Communications between you and the Family Law Facilitator / Self Help Attorney are not confidential. You should consult with your own attorney if you want personalized advice or strategy or to discuss your case confidentially.
